

## Carnival Corporation & plc Change Of Senior Independent Director And Presiding Director

Stuart Subotnick has stepped down from his role as Senior Independent Director and Presiding Director and Randall J. Weisenburger was elected by the company's Non-Executive Directors, acting in executive session, to take over as the Senior Independent Director under the UK Corporate Governance Code with immediate effect. "Randy Weisenburger is an excellent choice to serve as our presiding director," continued Arison. "Our company has benefited from his broad experience, leadership and wise counsel. Randy will serve the board and the company well in this new role."
